Anyone wishing to speak to the City Council/Planning Commission is asked to complete a Speaker's Card which can be found at the City Clerk's desk. The completed card should be submitted to the City Clerk prior to the Agenda item being called and prior to the individual being heard by the City Council/Planning Commission.
- ▶ **Public Comments (Non-Agenda Items):** Anyone wishing to address the City Council/Planning Commission on an item not on the Agenda may do so during the "Public Comments" period. In order to conduct a timely meeting, there will be a three-minute time limit per person for the Public Comments portion of the Agenda. State law prohibits the City Council/Planning Commission from taking action on a specific item unless it appears on the posted Agenda. Anyone wishing to speak to the City Council/Planning Commission is asked to complete a Speaker's Card which can be found at the City Clerk's desk. The completed card should be submitted to the City Clerk prior to the Agenda item being called by the City Clerk and prior to the individual being heard by the City Council/Planning Commission.
