## Grading (Rough grading plan check and permit fees are separate)

<b>Plan Check Fee</b>	\$320.00 + \$20.00 for each additional acre over 3.5
<b>Permit Fee</b>	\$200.00 + \$20.00 for each additional acre over 3.5

## Landscape

<b>Plan Check Fee</b>	\$60.00 + \$5.00 for each additional acre over 3.5
<b>Permit Fee</b>	\$30.00 + \$5.00 for each additional acre over 3.5

## Street Improvements, Sanitary Sewer, Construction and Storm Drain

\$0 - \$1,000	\$150.00
\$1,001 - \$10,000	\$150.00 + \$3.35 per \$100 in excess of \$1,000
\$10,001 - \$20,000	\$451.00 + \$2.25 per \$100 in excess of \$10,000
\$20,001 - \$50,000	\$676.50 + \$.70 per \$100 in excess of \$20,000
\$50,001 - \$100,000	\$886.50 + \$.45 per \$100 in excess of \$50,000
\$100,001 and over	\$1,111.50 + \$.27 per \$100 in excess of \$100,000

**Permit Fee equals 2.5 X the plan check fee**

**Los Angeles County plan check and permit fees for storm drains to be transferred to Los Angeles County, traffic signals to be operated by Los Angeles County, or street light systems, are to be paid separately by the developer to Los Angeles County**
